ADDENDUM NUMBER THREE TO AGREEMENT BETWEEN THE NORWEGIAN AGENCY FOR DEVELOPMENT COOPERATION AND TSNE MISSION WORKS (FISCAL HOST TO FINANCIAL TRANSPARENCY COALITION (FTC)), QZA-18/0372 EXECUTION OF THE FTC STRATEGY

1 BACKGROUND

- 1.1 The Norwegian Agency for Development Cooperation (Norad), represented by the Section for governance and transparency, and the Grant Recipient (jointly referred to as the Parties) have entered into an agreement dated 19.12.2018 (the Agreement) concerning QZA-18/0372 Execution of the FTC 2018-2020 Strategy Including Thematic Working Group (the Project). A first Addendum to this agreement regarding additional financing was signed on 04.12.2019. A second Addendum to the agreement was signed on 23.06.2021, involving additional financing and extending the agreement to 31.12.2022.
- 1.2 The Grant Recipient has submitted a request to Norad dated 07.02.2023 regarding additional financial support to the Project and an extension of the Support Period. The basis for this request is Norad's decision to discontinue support to FTC, and a mutual understanding that any support to FTC in 2023 shall be used to prepare for and conduct an orderly closure of the ongoing Project.
- 1.3 The Parties have agreed to amend the Agreement through this addendum number three (the Addendum), which shall be an integrated part of the Agreement.

2 EXTENSION OF THE SUPPORT PERIOD

2.1 The Support Period set forth in the Agreement shall hereby be extended to 31 December 2023.

3 ADDITIONAL GRANT

- 3.1 Norad shall, subject to Norwegian parliamentary appropriations and on the terms and conditions of the Agreement and this Addendum, provide an additional grant not exceeding NOK 3 700 000 (Norwegian Kroner three million seven hundred thousand) (the Additional Grant).
- 3.2 The Additional Grant shall be used exclusively to finance the Project, specifically preparing for and conducting closure of the Project, as specified in the budget attached as Annex A to this Addendum during the Support Period.
- 3.3 The Additional Grant shall be disbursed upon receipt of the countersigned document (this Addendum).

4 REMAINING CONDITIONS OF THE AGREEMENT

- 4.1 The final financial report shall be delivered to Norad by 31 May 2024, shall cover the entire support period and shall be submitted along with the final report referred to in Article 6.1 f) of the Specific Conditions. The final financial report shall include the content specified in Article 3 of the General Conditions and will show expenditure against the latest approved budget.
- 4.2 The final narrative report shall be delivered to Norad by 31 May 2024 and shall include the content listed in Article 4 of the General Conditions.
- 4.3 The final audit report shall be submitted to Norad by 31 May 2024 and shall cover the entire Support Period until the end of the Project.
- 4.4 All other provisions of the Agreement shall remain unchanged and in force.



5 ENTRY INTO FORCE AND DURATION

5.1 The Addendum shall enter into force on the date of the last signature and remain in force until all obligations arising from it have been fulfilled.

This Addendum has been signed in two -2- original copies in the English language, whereof the Parties keep one each. In the event of any discrepancies between this English language version and any later translations, the English language version shall prevail.
